*** AbHaulier *** Types of Licences and Prices

Installation of every copy of *** AbHaulier *** requires acceptance of 'Cascade's Simple Licence Agreement for *** AbHaulier ***' as included below. This Licence Agreement allows the licensee to install and use a specified number of copies of the program in accordance with the terms of the Agreement.

In all installations of *** AbHaulier ***, the first or only copy installed is the main installation, and any additional copies installed on other computers on the same network act as satellites to the first, enabling additional users to utilise the program to prepare and send notifications themselves.

A licensee wishing to set up more than one installation of *** AbHaulier *** at other locations can purchase or rent additional licences at a reduced rate, but each installation must be set up and operated in the same way.

Each installation of *** AbHaulier *** is designed to be customised to compile and send abnormal load notifications to bridge and police authorities from several different companies or company depots, all within the same computer network installation. For example, a company with several depots could use a single network installation of the program to submit notifications on behalf of and customised to each depot. Or a group of companies operating in the abnormal loads field could use a single network installation of the program to submit notifications customised to each company in the group. Likewise hauliers agents can submit notifications on behalf of the many companies they represent, using the contact details of the agent.

Under a standard licence, the number of separate companies or depots that can be set up on a single installation is now limited to five. Multiple company licences are available to allow the initial count of five to be extended in sets of five additional companies. Unrestricted and rental licences are also available. Rental licences have a minimum period of one year.

The *** AbHaulier *** Helpline, free for the first 3 months and optional thereafter, entitles the licensee to service upgrades for the version purchased during the currency of the Helpline together with telephone help during office hours. Any Helpline purchase must cover every copy of *** AbHaulier *** held by the licensee. Rental licences include full Helpline support.
